### OFFSHORE HELICOPTER SERVICES – ORANJEMUND

#### SCOPE OF WORK:

The scope of work includes but is not limited to the provision of two Agusta Westland 139 (AW139) or similar offshore helicopters in terms of specifications. The helicopter services are for Debmarine Namibia crew changes and crew transfers between vessels.

#### DOCUMENTATION TO BE SUBMITTED:

Interested entities with appropriate offshore equipment and experience as per the scope of work are required to provide full company profiles including the following:

- Full technical detail of the proposed offshore helicopters, please indicate whether the helicopters are owned or leased.
- The helicopter serial numbers if available.
- Age of the helicopter – less than 10 years.
- Valid Basic Aviation Risk Standard (BARS) compliance – green status requirement.
- Years of related experience as an offshore helicopter service provider.
- Company management organogram.
- Company registration documents.
- List of at least two corporate clients relevant to the scope of work.
- Number of management and staff employed. Sample by name of 5 x Pilots-in-Command and 5 x Co-pilots' experience (including offshore flying hours and type ratings) of pilots who could be offered for this contract.
- Air Operator Certificate (AOC) and Operations Specifications appropriate to the scope for operations in Namibia or South Africa and/or internationally.
